Response to our letter to Peter Wallace regarding non-union compensation was received from Kerry Pond (new HR E.D), who put the item on the March City

HR/COTAPSA meeting. The City HR/COTAPSA meeting took place on March 17th.

HR Officer went over:

- 1) Non-Union Compensation HR staff would not share the suggested COLA amount but alternately asked COTAPSA what they thought it would be.
- 2) Kilometrage Reimbursement while on Standby HR staff said mileage expense is a non-taxable benefit. E. Fearon strongly thinks otherwise, G. Ciardullo to re-confirm.
- 3) Review of Bereavement Leave Policy Comparison chart shared with Board as shared with City HR staff. Board to further discuss.
- G. Ciardullo left meeting (2:00 pm). H. Nicolson-Morrison continued.
- 4) Orientation for new non-union employees: Provision of information regarding COTAPSA Kerry Pond was requested to supply a COTAPSA membership form to new non-union employees.

The E.D referenced her comments to City HR staff on slow response time between the two groups.
